• Determine Number of Voting Units Represented

A total of 301 voting units were represented.

• Determine Number of Voting Units Assigned by Proxy

All 301 voting units represented were assigned by proxy to Mr. Cuarta by the Landowner, EPC Holdings 808, LLC. Mr. Cuarta was eligible to cast up to 301 votes per seat.
